## Scholarship & Financial Assistanceship Policy

### ✚ Free-shipping Programs:

The Institute has chosen to provide full-fledged and half-fledged scholarships to students from low-income families. To be eligible for this scholarship, students must submit appropriate documentation relating to family income, which will be thoroughly confirmed before the free ship is granted. Students who are receiving a scholarship or assistantship from another external funding agency or through the TFW system are not eligible for this scholarship.

### ✚ The Tuition Fee Waiver Program:

Candidates with an annual family income of less than Rs. 2.5 lakhs from all sources are eligible for a free studentship that covers solely the tuition price. The candidate must be a West Bengal resident. For B Tech, students must have a merit rank in the State Level Joint Entrance Examination (WBJEE) or the National Level Entrance Examination (JEE-Mains). ### ✚ Institute Undergraduate Scholarship:

Students who have completed their three-year diploma in the institute are eligible for a scholarship of Rs.60,000/- at a rate of Rs.10,000/- per semester.

### ✚ Institutional PG Scholarship

The Institute grants a scholarship of 20% on tuition costs, i.e., Rs.10000/- per semester, to external students who have a DGPA of 7.0 or higher in their last qualifying examination and wish to pursue M.Tech. M. Tech students would also receive a monthly stipend of Rs. 3000/-.

Any student who has finished a B. Tech programme at this institute and is accepted into an M. Tech programme at the same institute is eligible for a scholarship worth 20% of the tuition expenses.

Institute. M.Tech students will also receive a stipend of Rs.3000/- per month.

The Institute provides a scholarship of 20% on tuition costs, i.e., Rs.10000/- every semester is available to external candidates who have a DGPA of 7.0 or higher in their previous qualifying test and are interested in pursuing MCA.

### ✚ Sikh Scholarship:

The Institute's Sikh students also receive financial assistance from Gurudwaras, which help Sikh students from low-income families. Sikh students can qualify for a 50% discount on their tuition fees if they are members of the Sikh community. Only on tuition expenses is a 50% free ship/scholarship granted.

The students are responsible for any other costs. Sikh students will apply to the Gurudwara first, and then submit the check to the Institute's accounts department after receiving it. Only the second semester is eligible for this free ship/scholarship.

## Northeast States Scholarship Program

For students from the Northeast region, a scholarship of Rs.40,000/- will be awarded for admission to Lateral Entry (B. Tech) courses.

The following are the specifics of the Scholarship policy:

1. The candidate must be in possession of a valid Aadhaar card.
2. To be admitted to the B. Tech Lateral programme, a candidate must meet the minimal requirements.
3. Scholarships will be offered from the present fees structure at Rs. 7000/- each for the 3rd and 4th Semesters (2nd year) and Rs. 6500/- each for the 5th to 8th Semesters (3rd & 4th Year).
4. The student must not have a year gap to continue receiving the present scholarship.

## Scholarships for Siblings:

For B. Tech, M. Tech, and MCA programmes, a scholarship of 20% of the tuition cost will be provided to the direct sibling of a present or past student. It is necessary to submit proof of relationship.

## Employee Scholarship Program:


This Scholarship Program is offered to the children/immediate siblings of permanent Institute employees who work in any of the Institute's units and are paid on a regular basis. As of the 30<sup>th</sup> June of the relevant Academic session, the employee must have a minimum of three years of continuous work experience in the Institute. Only one child or immediate sibling of the employee will be eligible for the scholarship.

The percentage of the scholarship will be as follows:

Tenure of Service	Scholarship %
3 years - 5 years	10% on Tuition fee
5 years - 10 years	15% on Tuition fee
10 years - 15 years	25% on Tuition fee
15 years+	40% on Tuition fee

## Scholarship Withdrawal

1. Any youngster who is already getting financial support from the government is not eligible for a scholarship from the government, a private agency, or any other organization.
2. A student can only apply for one type of scholarship at a time and cannot combine scholarships.
3. The scholarship will be revoked if the student fails to present for an examination or receives a detention in any subject.
4. If the student does not maintain good attendance or if there is an allegation of misconduct, the scholarship will be revoked immediately.
5. The Board of Governance's decision on the continuation of any plan is final.


